### Registration Policy

Applications are processed on a first come, first served basis and must be received by TMRI Testing Office by the registration deadline. You are not guaranteed a seat unless your application is complete, fees have been received, and we have received a copy of your training certificate. Please note that you must send your application through the United States Postal Service. **TEST FEES ARE NON-REFUNDABLE.** If you arrive late to your test site, you will forfeit your test fees. To request that your test fee be transferred to a different test date TMRI Testing Office must receive your written request at least two business days before your scheduled test date or you will forfeit your test fees. The time frame to take the test should be one calendar year from your originally scheduled test date, otherwise your test fee will be forfeited. Additionally, if your training cannot be confirmed within one week of the test administration, your registration will be transferred to a future test date pending.

**Please note: Admission letters are emailed to confirmed applicants approximately one week prior to the scheduled test date.**
